The West Bengal Registration & Stamp Revenue Service Association has been working for decades to secure dignity and status of the members of our service.

We are happy to inform you that Sri Anup Kumar Mandal, ADSR(Records),R.A., Kolkata has secured 3<sup>rd</sup> rank in the training named Executive Programme for e-Governance sponsored by the Department of IT, Government of India coordinated by National Institute for Smart Government at T.A.PAI Management Institute, Manipal to acquire e-governance expertise.

A seminar was organized by our Association for the newcomers at Alipore and , documentations were provided with expert opinion.

Transfer orders of the DRs , DSRs and ADSRs came out in the month of February, 2010 and the much awaited transfer order of the DIGRs , DRs, DSRs and ADSRs is under process

We congratulate all the members for their dedicated efforts in collecting revenue to the tune of Rs 1927 crore (approx).

The order of Promotion of the SR to ADSR has been issued, but we feel sorry for the unnecessary delay causing them financial loser to a large amount.

The disparities noted in the order of C.A Benefit issued earlier have been removed. It may be noted here that CA benefit to a significant number of members is due, but due to non-availability of "Declaration of Asset Statement" and ACR, issuance of order is getting delayed. It is our humble request to all concerned to submit "Declaration of Asset Statement" and ACR in time.

A notification on amendment of West Bengal Services ( Trg. & Exam) Rules has been published by Home PAR (Trg) Department to include our service in the said rules and a demand

has already been made by our Association to the concerned authority for issuance of confirmation orders for the officers on probation who has completed two years of service and have passed the departmental examination. We have also demanded to take necessary steps by the Government to give second increment to the officers and also give arrears to the officers who were denied of second increment.

The five leave reserved posts in the Directorate has been upgraded from SR to ADSR.

The file for declaring our service as Integrated Service is under the consideration of the 5<sup>th</sup> State Pay Commission and we are expecting that a positive recommendation in the coming report of the Commission.

We are expecting the following achievement soon –


- 1) 2 posts of DIGs in 2 new Ranges, one in Nadia and another in Purba Medinipur
- 2) benefit of Career Advancement Scheme to the officers
- 3) implementation of confirmation orders on completion of two years service according to West Bengal Services ( Trg. & Exam ) Rules, and
- 4) the promotion of Sri Sudhangshu Sekhar Panja.

We have submitted some exhaustive memorandum before the Government for the betterment of our service.

The summary of receipts and expenditure for the year 2009-10 has been duly audited by our Auditor and the papers in this connection will be placed before you just after this by our treasurer for inspection and reference.
